FROM THE EXECUTIVE DIRECTOR

In early 2010, progress toward Sightline's goals—clean energy; a green economic recovery; compact communities; a more just and sustainable society—may feel slow. The Great Recession, budget woes, and bitter political division have sapped last year's high hopes.



But actually, we remain in a period of rapid change. Hundreds of millions of dollars are flowing to clean-energy projects in the Northwest states, seeding a green economic recovery. The Northwest's elected representatives are championing a sweeping national climate law. British Columbia affirmed its world-leading carbon tax shift at the polls less than a year ago. A raft of innovative state and local initiatives are underway.

And Sightline has played a key role in each of these developments, thanks to you. We've shaped laws and policy proposals at local, state, provincial, and national levels too many times to recount here. Our *Cap and Trade 101* has become one of the world's best-read guides to climate policy.

Meanwhile, we maintained our longer-term efforts building momentum for future changes through the *Cascadia Scorecard*, *Sightline Daily*, *Sightline Flashcards*, and *The Daily Score*. In 2009, we increased our email subscriber ranks to 13,000. These leadership-heavy readers reported sharing our work with others more than ever. Website visitors grew by 23 percent: some 436,000 people used Sightline. org. We generated 172 high-quality media stories in the Northwest. And thanks to our supporters, we ended 2009 in sound financial shape.

The year 2009 was among Sightline's best ever, but we're determined to make 2010 surpass it. We are conscious of new obstacles, but we are accelerating. In the quest we and our supporters are on, change has rarely come how and when we expected. But it has come. And we are doing everything we can to bring it faster, to make the Northwest a place worthy of our children and grandchildren.

DONOR PROFILE

15 Years of Giving: Linda Moulder and Jerry White "walk the walk"

Two Sightline supporters understand ecological limits and sustainable living, and they've put this knowledge rigorously to the test.

Linda Moulder and Jerry White of Spokane, Washington have been fans of Sightline Institute since the very beginning. The year 2009 marked their 15th anniversary—not to one another—but of their giving to Sightline Institute. "We were long-time members of Worldwatch Institute, so when Alan Durning began Sightline we immediately joined." Not long after, they

received their copy of *This Place on Earth*, Alan Durning's book about his personal journey from world wanderer to founder of Sightline Institute, published in 1996. "We were very moved," they said. And they've been members ever since.

The sense of place that forms the theme of the book really resonated with both Linda and Jerry. "The Pacific Northwest is home," Linda affirms. "We have lived in both New Zealand and Rhode Island," Jerry explains. "The East was very crowded and it made me miss the open spaces of the West. In New Zealand the lack of diversity and habitat made me long for home."

Another motif from *This Place on Earth* also caught their eye: "We agree that if there is any hope for sustainability, the Pacific Northwest is probably the place it will occur."

Jerry and Linda know of what they speak. Trained as biologists, they both understand ecological limits and the impacts of large populations, especially when they exceed carrying capacity. And they've put this knowledge rigorously to the test.

Linda began practicing sustainable living back in the 1970s. "My first husband and I, along with another couple, bought 30 acres of land," she explains. "We had no commercial electricity for five years and learned to do without all the popular electrical appliances. Our well was very poor and we learned to live with very little water," which is why they established the first approved composting toilet in Spokane County, back in 1976. "This experience has colored my entire adult life," Linda says. "I learned I don't have to 'consume' to be happy."



Jerry's been busy, too.

"I built an energy-efficient house where our electric bill is less than our phone bill," he explains with evident pleasure. "We use wood to heat the house, hot water, and hot tub." Jerry also set up and operates the composting program at the Unitarian Universalist Church of Spokane.

In 2004, Linda and Jerry became founding members of the Cascadia Stewards Council. "We appreciate the research and education efforts of Sightline," they explain. "Sightline is an organization that works on issues that affect Pacific Northwesterners directly. They are a professional organization that carefully researches issues before taking a position."

Knowing them a little better now, it is easy to see what Jerry and Linda value in Sightline and why they have been such dedicated supporters for more than 15 years. At Sightline, we do not take that for granted and are forever grateful.

"Sightline is an invaluable ally to all of us working on climate policy in the Northwest. Sightline's staff has demonstrated a unique and powerful ability to provide thorough research, well-reasoned arguments, and helpful communication tools in a rapidly changing climate policy environment. 


