Annually, a sub-committee of the board reviews the Executive Director's self-evaluation, meets with the ED to discuss it, and solicits feedback from and meets with senior staff to judge their perspective of the Executive Director's effectiveness. The sub-committee then creates a report that makes a recommendation to the full board on whether and how much to increase the Executive Director's salary and/or authorize a bonus, based on the members' evaluation of the quality of the Executive Director's performance.
