Per "Note 1 - Summary of Significant Accounting Policies" in the 2024 audited financial statements, the 2023 functional expenses were reclassified to support a consistent allocation method between the current year (2024) and prior year (2023) presented.

The most significant reclassification was to functional expenses, updating the payroll and related expenses allocation to conform with the current year's method of allocation. This reclassification resulted in program expenses decreasing \$231,638, management and general expenses increasing \$205,931, and fundraising expenses increasing \$25,707.
